What data do we collect?

Planning Potential collects the following data:

- Personal identification information (Name, email address, phone number, postal address etc.)

How do we collect your data?

How we store your data?

You have the right at any time to stop Planning Potential from contacting you.

What are your data protection rights?

The right to access – You have the right to request Planning Potential for copies of your personal data.

The right to rectification – You have the right to request that Planning Potential correct any information you believe is inaccurate. You also have the right to request Planning Potential to complete the information you believe is incomplete.

What types of cookies do we use?

Our website uses a maximum of four different cookies which are purely functional whilst the session is active. Two of them expire 30 minutes after the last page they look at is accessed.

- **Functionality** – Planning Potential uses these cookies to recognise you as an unidentified individual as you browse our website throughout your session. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
